CONGRESSIONAL BILL NO. 6-10, C.D.1, C.D.2

Public Law No. 6 - 22

AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 5-16, 5-88, 5-119, 5-121 and 5-136, by amending section 210 to provide for program review by the Congress of the Federated States of Micronesia for first year or first time federal grant applications, proposals, or preexpenditure reports and applications, proposals, or preexpenditure reports requesting \$50,000 or more, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 210 of title 55 of the Code of the Federated
2 States of Micronesia is hereby amended to read as follows:

3 "Section 210. Program Fund.

4 (1) Definitions. The term 'programs' shall include
5 all funds made available to the Federated States of
6 Micronesia pursuant to sections 221(a), 221(c), and 224
7 (program funds) of the Compact of Free Association and
8 United States statute through categorical, block,
9 consolidated project, or discretionary grants. It shall
10 also include grants received from any international or
11 United Nations organization. It shall not include other
12 funds received pursuant to the Compact of Free Association,
13 or funds received from the United States Department of
14 Interior derived from its annual departmental budget, or
15 those funds known as transition funds, nor indirect costs
16 received for the administration of Federal programs.

17 (2) Program review. Prior to the submittal of any
18 first year or first time application, proposal, or
19 preexpenditure report or any application, proposal, or
20 preexpenditure report that requests funding for \$50,000 or
21 more to any United States Federal agency, the President or
22 his designee shall submit such application, proposal, or

1 preexpenditure report to the Congress of the Federated
2 States of Micronesia for its review and approval by
3 resolution. If Congress is not in session, the appropriate
4 committee shall review and approve the application,
5 proposal, or preexpenditure report. The scope of such
6 review shall be complete, with the ability to approve any
7 aspect of any application, proposal, or preexpenditure.
8 The approval of any application, proposal, or
9 preexpenditure report by the appropriate committee shall
10 not obligate funds from the National Treasury where they
11 were not otherwise appropriated pursuant to law. The
12 Congress or the appropriate committee shall complete its
13 review within forty days of submission.

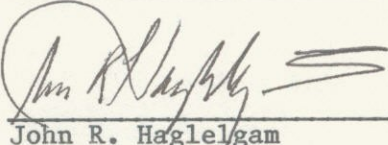
14 (3) Program Fund. There is hereby created within the
15 National Treasury of the Federated States of Micronesia a
16 Program Fund into which all funds received by the Federated
17 States of Micronesia from program sources, as defined
18 in subsection (1) of this section, shall be deposited. The
19 President or his designee shall notify Congress of grant
20 awards and deposits to the Fund. Funds shall be adminis-
21 tered and withdrawn by the President or his designee.
22 Funds derived from United States program sources shall be
23 accounted for and shall be in accordance with reporting
24 requirements of the United States Government. Initially,
25 the Program Fund shall consist of all prior year un-

1 obligated balances of program funds and all program funds
2 designated for the National Government of the Federated States
3 of Micronesia and made available beginning October 1, 1982.

4 (4) Program reports. Prior to the submittal of any
5 application, proposal, or preexpenditure report to any United
6 States Federal agency, the President or his designee shall
7 submit such application, proposal, or preexpenditure report to
8 the Congress of the Federated States of Micronesia, whether or
9 not its review and approval by the Congress of the Federated
10 States of Micronesia is required by subsection (2) of this
11 section."

12 Section 2. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its becoming
14 law without such approval.
