## AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by amending section 604, and by further amending sections 602, 603 and 607, as amended by Public Law No. 5-21, for the purpose of updating and revising the Imprest Revolving Fund Act of 1982, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 602 of title 55 of the Code of the Federated
2	States of Micronesia, as amended by Public Law No. 5-21, is hereby
3	further amended to read as follows:
4	"Section 602. Purpose. The purpose of this subchapter
5	is to establish six ongoing imprest revolving funds to
6	provide, subject to the provisions of section 604 of
7	this subchapter, sources of advanced funding for authorized
8	expenses of the Federated States of Micronesia Mission to
9	the United Nations, New York; the Federated States of
LO	Micronesia Embassy, Washington, D.C.; the Federated States
11	of Micronesia Consulate, Honolulu; the Federated States of
L2	Micronesia Consulate, Guam; the Federated States of
L3	Micronesia Embassy, Tokyo, Japan; and the Federated States
L4	of Micronesia Embassy, Suva, Fiji. Such authorized
15	expenses shall include those incurred during official
16	travel by qualified College of Micronesia-FSM employees and
17	officials, by any individual on a National or State
18	Government travel authorization, and medical referral
19	patients and their attendants."
20	Section 2. Section 603 of title 55 of the Code of the Federated
21	States of Micronesia, as amended by Public Law No. 5-21, is hereby

22 further amended to read as follows:

1	"Section 603. Establishment. There is hereby established
2	an ongoing imprest revolving fund within the General Fund
3	for each of the following offices of the National
4	Government of the Federated States of Micronesia:
5	(1) Federated States of Micronesia Mission to
6	the United Nations, New York;
7	(2) Federated States of Micronesia Embassy,
8	Washington, D.C.;
9	(3) Federated States of Micronesia Consulate,
10	Honolulu;
11	(4) Federated States of Micronesia Consulate,
12	Guam;
13	(5) Federated States of Micronesia Embassy,
14	Tokyo, Japan; and
15	(6) Federated States of Micronesia Embassy,
16	Suva, Fiji."
17	Section 3. Section 604 of title 55 of the Code of the Federated
18	States of Micronesia is hereby amended to read as follows:
19	"Section 604. Authorized uses of the funds. Each fund
20	established pursuant to section 603 of this subchapter may
21	be utilized as a source of advanced funding for the
22	following authorized expenses of the office for which that
23	fund was established:
24	(1) Each fund established pursuant to section 603
25	of this subchapter may be utilized as a source of advanced

1		funding for medical expenses of personnel in the office
2		for which that fund was established if and to the extent
3		that health insurance provided for such personnel by or
4		through the National Government of the Federated States of
5		Micronesia may reasonably be expected to cover such
6		expenses. Advanced funds which are subsequently
7		determined not to be covered by such insurance shall be
8		promptly reimbursed by the personnel to or for whom paid.
9		(2) All of the funds established pursuant to
10		section 603 of this subchapter may be utilized as sources
11		of advanced funding for authorized expenses incurred
12		during travel by:
13		(a) employees and officials of the College of
14		Micronesia-FSM and any individuals who have been issued a
15		valid National or State Government travel authorization; and
16		(b) medical referral patients and their
17		attendants who have been issued valid travel authorizations.
18		(3) The Secretary of Finance of the National
19		Government of the Federated States of Micronesia shall
20		determine 'authorized expenses' for the purposes of
21		subsections (1) and (2) of this section through
22		the establishment of policies and procedures.
23		(4) The funds shall not be utilized for any
24		purpose other than as permitted by this section."
25	Sect	ion 4. Section 607 of title 55 of the Code of the Federated

1	States of Micronesia, as amended by Public Law No. 5-21, is h	ereby
2	further amended to read as follows:	
3	"Section 607. Authorization.	
4	(1) The sum of \$140,000, or so much thereof a	as may be
5	necessary, is hereby authorized to be used within t	:he
6	General Fund of the Federated States of Micronesia	for the
7	purpose of funding the imprest revolving funds. The	ne sums
8	authorized by this subsection shall be apportioned	as
9	follows:	
10	(a) Federated States of Micronesia	
11	Mission to the United Nations, New York	\$40,000
12	(b) Federated States of Micronesia	
13	Embassy, Washington, D.C	.40,000
14	(c) Federated States of Micronesia	
15	Consulate, Honolulu	.20,000
16	(d) Federated States of Micronesia	
17	Consulate, Guam	.10,000
18	(e) Federated States of Micronesia	
19	Embassy, Tokyo, Japan	.20,000
20	(f) Federated States of Micronesia	
21	Embassy, Suva, Fiji	.10,000
22	(2) All funds authorized by this subchapter s	shall be
23	allotted, managed, administered, and accounted for	in
24	accordance with applicable law, including, but not	limited
25	to, the Financial Management Act of 1979. The allo	ttee

1	shall be responsible for ensuring that these funds, or so
2	much thereof as may be necessary, are used solely for the
3	purpose specified in this act, and that no obligations are
4	incurred in excess of the sum authorized."
5	Section 5. This act shall become law upon approval by the
6	President of the Federated States of Micronesia or upon its
7	becoming law without such approval.
