## AN ACT

To address National transportation matters by further amending title 55 of the Code of the Federated States of Micronesia, as amended, by amending section 614 for the purpose of providing for the operation and maintenance of all vessels controlled by the Department of Transportation and Communication, and by appropriating the sum of \$150,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1992, to provide funding for a feasibility study and professional services associated with financial structuring for the purchase, in whole or in part, of the venture known as Continental Air Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 614 of title 55 of the Code of the Federated

2 States of Micronesia is hereby amended to read as follows:

3 "Section 614. Purpose. The purpose of the Fund is to

4 establish an ongoing revolving fund to allow appropriations

for and revenues from the operation of all National

6 Government vessels under the direct operational control of

the Department of Transportation and Communication to be

used for the ongoing operation and maintenance of such

9 vessels."

10 Section 2. The sum of \$150,000, or so much thereof as may be

11 necessary, is hereby appropriated from the General Fund of the

12 Federated States of Micronesia for the fiscal year ending September

13 30, 1992, to provide funding for a feasibility study and professional

14 services associated with financial structuring for the purchase, in

15 whole or in part, of the venture known as Continental Air Micronesia.

Section 3. All funds appropriated by this act shall be allotted,

17 managed, administered, and accounted for in accordance with applicable

18 law, including, but not limited to, the Financial Management Act of

19 1979. The allottee of the funds appropriated under this act shall be

20 the President of the Federated States of Micronesia or his designee,

21 who shall be responsible for ensuring that these funds, or so much

22 thereof as may be necessary, are used solely for the purpose specified
